OUR PROGRAM: "The Affordable Care Act: What to Expect Now" Guest Speaker: Judith Parker

Although the US Supreme Court won't rule until June on some or all of the health care law, we all need to understand how the law might affect us. Judith Parker has given numerous presentations on health care, including at the 2011 AAUW Missouri convention, and she will help us navigate the intricacies of this important legislation.

Judith Parker is a consultant for the Missouri Alliance for Retired Americans. She is a graduate of Saint Louis University, Washington University, and Harvard's JFK Program for Senior Executives. She has served as president of the Special School District Board of Education; has been an adjunct instructor at Maryville University; was executive director of two nonprofits, cofounder of three, and board member of several others; and was director of the St. Louis County Department of Human Services.

Our branch provided 4 raffle items including a popup book donated by Nancy Hutchins on the History of the Bra. The raffle raised \$541 to be used to sponsor future AAUW Interbranch Council projects. The highlight of the day was presenting the Barb Lackritz Leadership Award to Diane Ludwig. Diane has dedicated herself to AAUW in so many ways she was very deserving of the award. Diane and Barb Lackritz were longtime friends so it made the Award very special to Diane. Every year IBC awards the "ANNIE" to the branch who has the largest representation at the IBC Spring Fling. SECOND ANNIVERSARY OF AFFORDABLE CARE ACT

March 23, 2012 marked the second anniversary of the signing of the Affordable Care Act into law. Thanks to this law over a million Missouri citizens are receiving benefits and requiring health insurers to play by new rules that prohibit dropping coverage when people get sick or selling policies with lifetime and annual limits. After 2014 the law will stop insurance companies from discriminating against anyone with a pre-existing condition and will protect women from being charged higher premiums just because of gender. Over one million Missourians, many of them women, are also getting preventive screenings like mammograms and colonoscopies in their private health plans with no cost-sharing. Some 39,667 young adults in Missouri gained insurance coverage as of June of last year when the reform law required health plans to allow parents to keep children under 26 years of age on their family's policies. Starting this summer women will have access to free comprehensive contraception coverage through either employer or their insurer. This bill has helped to change the quality of health care for many Missouri citizens. We must be vigilante to insure this bill remains uncharged by insurance companies and politicians who would like to remove the benefits to women's health. In the upcoming elections and campaigns health care should be an important issue for discussion.

WHAT IS THE "EVERYTHING TAX"?

What began as the "Fair Tax" is now known as the "Everything Tax," a tax on most everything Missouri families and seniors buy every day. It's currently a proposed constitutional amendment being pushed by billionaire Rex Sinquefeld. It would replace the state income tax with a new, 10%, statewide, sales tax on everything you buy every day. If you are asked to sign a petition putting this on the ballot, please **DECLINE**. Sinquefeld has a lot more money to sway people to his way of thinking than organizations who are familiar with its effects; so if it gets on the ballot, it will be hard to fight.

At a time when so many Missourians are struggling to make ends meet, the Everything Tax would make things worse by creating a new, 10-percent sales tax. Missouri families will be forced to find more room in their budgets for things like milk, bread, baby food, diapers, health insurance benefits, emergency room visits, in-home nursing care costs, and car insurance payments, just to name a few.

The Everything Tax hits senior citizens especially hard. Living on a fixed income, the Everything Tax would add a new tax on their food, medicine, and in-home or nursing home care.

In addition to making you pay more for most everything you buy every day and being especially hard on seniors and working Missouri families, the Everything Tax makes Missouri's already bad budget situation worse. First of all, sales tax revenues in Missouri have decreased over the last five years, not increased. In 2006 the state collected \$1.96 billion in sales taxes. In 2011 it collected \$1.76 billion, a reduction of \$200 million in revenue. Typing the state's budget to a decreasing pot of money is bad fiscal policy. Secondly, and perhaps more importantly, creating a new, 10-percent, statewide sales tax to replace the state income tax will result in a massive budget shortfall. When fully implemented in 2016, the Everything Tax will create a shortfall of \$3.2 billion. That's on top of the state's current budget challenges. To cover the shortfall, the state will have to cut back crucial programs, irreparably harming our ability to compete effectively in the long run.

LEGAL ADVOCACY FUND - CASE UPDATE: VICTORY IN TITLE IX SUIT

In January, the U.S. Court of Appeals for the 7th Circuit overturned a lower court's dismissal of the LAF-supported case, *Parker v. Franklin County Community School Corporation*, an Indiana high school athletics lawsuit. The suit alleges that the scheduling of girls' basketball games violated Title IX and the Equal Protection Clause of the 14th Amendment to the Constitution. The plaintiffs argue that the majority of boys' games were played in prime time — on Friday and Saturday nights — while the girls' games were relegated to weeknights. They say these schedules unfairly put academic burdens on the girls by forcing them to compete on school nights, discouraging crowd support, and making the girls feel like second-class athletes. Originally, the case was dismissed by the U.S. District Court for Southern Indiana, which held that school districts are "arms of the state" that are immune from suit in federal court for constitutional violations. On January 31, that ruling was overturned by the 7th Circuit, which remanded the case back to the lower court to determine "whether any genuine issues of material fact exist as to the plaintiffs' claims."

"MISSOURI WOMEN'S REPORT"

Deb McWard attended the press conference announcing the findings of the "Missouri Women's Report" on April 16th. The report made the front page of the *Post-Dispatch*. Deb quotes the *St. Louis Beacon* in an article written March 15 by Mary Delach Leonard of the *Beacon* staff:

"Here are a few eye-opening numbers regarding the status of women in the Show-Me State:


- More than one-third of Missouri women – 36 percent – live in poverty, compared to 31 percent of men. (The study defines poverty as 200 percent of "federal poverty level" which some researchers believe, the study says, is a more realistic guideline. For example, in 2010, 200 percent of the FPL for a family of three was \$35, 136.)
- 32 percent of Missouri women who are poor or working poor have no health insurance.
- On average, the earnings of Missouri women are three-fourths of men's earnings.

There are other worrisome statistics in the "Missouri Women's Report," a recently released study by the University of Missouri Office of Social and Economic Data Analysis. The report was commissioned by the Women's Policy Alliance to determine how the status of Missouri women has fared in the decade since the Institute for Women's Policy Research gave the state a grade of "C" in its 2002 national report "Status of Women in the States."

Military Justice System in the St. Louis Area**

During the Civil War, hundreds of Confederate-sympathizing women passed through the hands of the military justice system as prisoners of war in and around St. Louis. Those deemed guilty of the most serious infractions were confined to the nearby Alton prison, the former Illinois state penitentiary, for their part in assisting the Confederate war effort. The women imprisoned in Alton came from states primarily along the Mississippi River, especially Missouri, and each spent many months in custody. This presentation focuses on those women and their experiences.
