PAY DISCRIMINATION CASE UPDATE

Virginia LeBlanc is the former director of the Hudson and Holland Scholars Program at Indiana University, a scholarship program that primarily serves African American students. She filed a complaint in federal district court against the university claiming gender and pay discrimination after allegedly facing resistance when she tried to resolve the pay disparity internally. AAUW adopted her case in December 2012.

Recently, LeBlanc and her legal team completed their first round of information discovery, and settlement talks are scheduled for March. If necessary, the case will go to trial in April 2014.

AAUW STANDS WITH SURVIVORS OF MILITARY SEXUAL ABUSE

On January 23, the House Armed Services Committee held a hearing on the widespread sexual misconduct at Lackland Air Force Base in San Antonio, Texas, where all members of the Air Force attend basic training. AAUW Board of Directors member Kathy Braeman and Program Manager Holly Kearl tried to attend the hearing, but most of the seats were reserved for members of the military, so they had to watch it on television from an overflow room.

Kearl wrote a blog post about the hearing that focused on how the Air Force said they did not talk with the survivors who had come forward before they made recommendations for improvement. How can they hope to fix a crime without talking to survivors of that crime? Her post led to an interview and an invitation to write for the Huffington Post about the military sexual assault survivors who are participating in the LAF-supported lawsuits.

With the 2012 elections over, it's time to hold legislators' feet to the fire. AAUW of Missouri now has a state-of-the-art legislative tracking tool to help us take effective and timely action on policy issues in our state. AAUW MO will implement this tracking tool in the next few weeks.

CQ StateTrack allows the AAUW staff in Washington, D.C., to work with our state leaders to track state legislation that affects our AAUW priority issues. We will use CQ StateTrack to create a profile for our state, which includes a set of keywords, committees, and legislators that will be used in automatic searches of state bills. The searches will automatically generate email alerts when state legislation containing one of our keywords is introduced, being heard in committee, or ready for a floor vote. The search can also generate web reports to give us a snapshot of what the state legislature is considering at any one time, based on our state's keywords and key issues. We have chosen two key words: voter identification & pay equity. We are currently exploring other possibilities.

CQ StateTrack is a game-changer for Missouri's advocacy on AAUW priority issues. Through its policy experts in Washington, D.C., AAUW already has the capability to track federal legislation down to this specific, instantaneous level, and CQ StateTrack will extend that capability to state legislation in our state.

We will embed the CQ StateTrack legislative report on our AAUW MO website so that our site becomes a go-to place for up-to-date information on legislation affecting women and families in Missouri. We will also include summaries from the CQ StateTrack legislative report in this newsletter to keep everyone up to date and ready to take action when needed. With this new service, AAUW of Missouri will be one of the first advocacy organizations in our state to know about pending legislation. INTERNATIONAL RELATIONS LECTURE SERIES

March 12, 2013 - Tuesday morning, 10:45 AM "Women's Political Representation Worldwide: Progress, Disparities, Benefits, and Consequences," by Farida Jalalzai, associate professor of political science at the University of Missouri-St. Louis, whose research analyzes the representation and behavior of women and minorities in politics and the role of gender in the political arena. She has published articles about women prime ministers and presidents, and her book on this subject, Shattered, Cracked or Firmly Intact: Women and the Executive Glass Ceiling Worldwide, will be published by Oxford University Press in 2013. Professor Jalalzai chairs the Race, Gender, and Ethnicity section of the Northeastern Political Science Association. She also serves as faculty advisor for the Sue Shear Institute for Women in Public Life Leadership Academy.

"Sex Trafficking Globally and Locally," to be presented by a speaker from International Crisis Aid. 1.2 million children are trafficked for sex every year. This is in addition to the millions held captive by trafficking. Every two minutes a child is being prepared for sexual exploitation. Almost 300,000 American children are at risk for trafficking into the sex industry. The average age American girls become victimes of sex trafficking is 12-14 years old. The total market value of illicit human trafficking is estimated to be in excess of \$32 billion. Awareness is the first step to finding a solution to the problem because you cannot fix a problem you don't know exists. The International Crisis Aid (ICA) is a St. Louis-based non-profit organization that is fighting this battle head on. Pat Bradley, a local businessman, founded ICA in 2000. ICA's work consists of disaster relief, feeding programs, orphanages, medical clinics, and rescuing victims of sex trafficking. ICA has done work and set up safe houses in countries such as Afghanistan, Pakistan, Ethiopia, Cambodia, North Korea, Indonesia, Haiti, and the United States. ICA has been rescuing girls from sex trafficking since 2006 and has rescued 145 girls worldwide. ICA is in the midst of opening its first safe home in St. Louis for local victims of sex trafficking. Once rescued and taken to a secure home, the girls receive food, shelter, medical care, legal support, counseling, and education.

CROSSING THE LINE TALK AT THE UNITED NATIONS

LAF Program Manager Holly Kearl, co-author of AAUW's 2011 report, Crossing the Line: Sexual Harassment at School, will speak about sexual harassment in schools during the 2013 United Nations Commission on the Status of Women (CSW). The theme this year is Elimination and Prevention of All Forms of Violence against Women and Girls, and the panels are held in venues near the United Nations over the two weeks of the CSW meetings. The AAUW panel will take place during the parallel events for nonprofit organizations. Kearl will talk about AAUW's findings and recommendations, and three high school students will join her to share their experiences.

EQUAL PAY IS NOT JUST A MATTER OF PRIDE-FOR MANY WOMEN IT IS A MATTER OF SURVIVAL!

......Speak out on Equal Pay Day, April 9thParticipate in the Equal Pay Rally, April 17th

In 2013, we celebrate the 50th Anniversary of the Equal Pay Act, which made it illegal to pay men and women different wages for the same work. Yet fifty years after the passage of that act, women are still making on the average twenty to twenty-five percent less than men are for the same job (African American and Hispanic or Latina women tend to make even less). According to the AAUW research report, Graduating to a Pay Gap, "when individual women's losses due to the pay gap are aggregated across all working women for a generation, the results are staggering. College-educated women who entered the workforce between 1984 and 2004 have lost \$1.7 trillion in income due to the pay gap." In the 2012 Missouri legislative session, Representative Stacy Newman introduced a bill to set up a commission to study the issue of pay equity in Missouri. As you can guess, the bill never made it to the floor for a vote. One of our male representatives commented to me that it was a "trivial bill." I sincerely doubt he would think it was trivial if his paycheck were less because of his gender. We must continue to fight this narrow thinking. Women's voices must speak in unison demanding financial security for themselves and for their families. I was thrilled when President Obama said in his Inaugural speech, "Our journey is not complete until our wives, our mothers and daughters can earn a living equal to their efforts." Let's pick up that gauntlet and vigorously participate in activities to enact laws that strengthen the Equal Pay Act of 1963. Let's educate the public that there is nothing "trivial" in being denied a fair and equal wage.

The month of April offers two specific opportunities for active participation in the pay equity battle. Tuesday, April 9, is Equal Pay Day. This day symbolizes "the point in the next year to which a woman must work to achieve pay equity for the previous year." This is an opportunity for AAUW branches all across Missouri to "mobilize around the issue to educate your community and continue the process of change." The AAUW Pay Equity Resource Kit has great ideas on activities for that day. It is also an excellent source for facts and figures about pay equity. *Kirkwood–Webster Groves Branch AAUW RE:News* page 5 On Wednesday, April 17, AAUW, together with the League of Women Voters and the National Organization of Women, is sponsoring a Rally at the Capitol Rotunda. AAUW Missouri is pleased to be participating in this collaborative event with these two organizations. Other organizations and individuals who believe in equal pay as a priority issue for all women are also invited to join the rally. The event timeline is from 11:30 a.m. until 1:30 p.m. Following the rally, participants will be invited to deliver special "Pay Day" candy bars to their state representatives and senators. Each branch will receive specific details as we continue to develop plans.
