AAUW WEBSITES HAVE NEW LOOK AND NEW FEATURES

Redesign of the AAUW national website, which can be accessed at http://www.aauw.org/, has incorporated our new logo and new features. If you've used the website in the past, you may find some information relocated. The "search" feature has been improved to make it more powerful, so finding what you need may be easier.

The AAUW Missouri website (http://aauwmo.aauw.net/) also has a fresh design, though features remain the same. We expect the Kirkwood-Webster Groves Branch website (http://kwg-mo.aauw.net/) to receive its makeover any time now. If you need a reminder of the passwords for the members-only sections of these two sites, please e-mail Lynne Roney at lynneroney@sbcglobal.net.

Members are encouraged to use the website to pay dues, contribute to AAUW Funds, vote on issues, and keep their membership information up to date. To use the many members-only features on the national website, you will need to register. If you previously registered on the old website, your member number and password still work, and in fact only one login is now needed to get to the Member Services Database. If you haven't registered yet, this would be a good time to do so! Here's a step-by-step guide: Go to http://www.aauw.org. At the top of the page, click on "Login." Then click on "you will need to register" and follow the directions.

Your member number is on the address label of your Outlook magazine (or contact our treasurer or membership chair to get it). Be sure to write down the password you create.

To use the AAUW website for dues payment: Go to http://www.aauw.org/, scroll down to the bottom of the page, and click on Member Tools. Log in with your member number and password. Scroll down to Member Services Database, click on "Visit here," then enter the database.

On the left click on "Renew My Membership," and follow directions provided. You will need to provide your credit card information. In this database you can also check and correct contact info, see your contribution history and make a contribution, contact branch or state officers, and see your branch roster. *Kirkwood–Webster Groves Branch AAUW RE:News* page 3 The Member Services Database is also useful for branch and state officers, who can update the AAUW database, download the branch roster, download the list of national members (members at large), see college/university information, and report new members and renewals.

INTERNATIONAL RELATIONS LECTURE SERIES

April 9, 2013 - Tuesday morning, 10:45 AM "Sex Trafficking Globally and Locally," to be presented by a speaker from International Crisis Aid. 1.2 million children are trafficked for sex every year. This is in addition to the millions held captive by trafficking. The International Crisis Aid (ICA) is a St. Louis-based non-profit organization that is fighting this battle head on. Pat Bradley, a local businessman, founded ICA in 2000. ICA's work consists of disaster relief, feeding programs, orphanages, medical clinics, and rescuing victims of sex trafficking. ICA is in the midst of opening its first safe home in St. Louis for local victims of sex trafficking. Once rescued and taken to a secure home, the girls receive food, shelter, medical care, legal support, counseling, and education.


