OUR PROGRAM: Legislative Update: What's the Latest in Jefferson City? What Can You Do?

Guest Speaker: State Rep. Stacey Newman

Budget cuts that affect education. Voter ID. Bills making it more difficult to prove employment discrimination. These are some of the issues coming before the 96th Missouri General Assembly. Come to hear an update and participate in a discussion with Rep. Stacey Newman, who represents the 73rd House District, which covers Clayton, Richmond Heights, Maplewood, and parts of Ladue, Webster Groves, and Brentwood.

Rep. Newman was elected in a special election in November 2009. Before her service in the Missouri House, she was employed as a political consultant. She served as a founder and the executive director of Harriett's List, a statewide political action committee honoring the legacy of Harriett Woods, former Missouri Lt. Governor. Previously she served as the executive director of the Missouri Women's Coalition and the women's vote director for both the Missouri Democratic Party and Democratic National Committee. She also was employed as a flight crew member with Trans World Airlines from 1979 to 1992.

Rep. Newman has served on the board of directors of PROMO PAC, the statewide equality group; the Institute for Women's and Gender Studies, University of Missouri St. Louis; Missouri Progressive Vote Coalition; the National Women's Political Caucus of Metropolitan St. Louis; Central Reform Congregation and Congregation Temple Israel. She is a member of the National Women's Legislative Lobby. She received two undergraduate degrees in both fine arts and education from Emporia State University, Kansas. Rep. Newman taught speech and theatre at the American School in London, England, after graduation.

Rep. Newman, a Democrat, is chair of the House Progressive Caucus and serves on the Task Force on Prevention on the Prevention of Sexual Abuse in Children and the Attorney General's Domestic Violence Task Force, as well as a number of committees.

CROSSING THE LINE: SEXUAL HARASSMENT AT SCHOOL

Help AAUW Spread the Word about Our Latest Research Report! Crossing the Line: Sexual Harassment at School, AAUW's new research report on sexual harassment in middle and high schools, which was released online in November, has gotten significant media attention from a number of outlets, including the Associated Press and the New York Times. This report, the first of its kind in 10 years, provides valuable information for all of us who are concerned about the next generation. Parents, teachers, administrators, policy makers, and, most of all, students need this report to shed light on the issue of sexual harassment in schools. AAUW is ready to amplify the conversation and give people the facts and best practices they need to work toward a solution. AAUW needs us to get involved in the discussion while also taking advantage of the opportunity to show our communities what AAUW is all about. This report is an outstanding chance to work with local PTAs/PTOs, school districts, Girl and Boy Scout troops, the YWCA, and the YMCA. If you can, contact a nearby school to find out if there is a Title IX coordinator and if that person's name is publicized. Ask how many sexual harassment complaints have been filed recently and share a copy of the report. Hard copies are available from ShopAAUW (on www.aauw.org) or the PDF version can be printed. A PowerPoint presentation can be downloaded (www.aauw.org/learn/research/crossingtheline.cfm); it comes with a script and has everything needed to make a presentation. Crossing the Line will have an impact only if people read and use it. Please ensure that educators, parents, and students have copies of the report.

CALLING ALL ARTISTS!

The 2012 AAUW Art Contest is already underway, and there is still time to submit your art or photography! The AAUW Art Contest is a showcase of the artistic talents of AAUW members. The contest is open exclusively to AAUW members who may submit their original artwork January 4 through January 31, 2012. Previous non-winning entries from past years can be re-submitted for this year's contest! The six winning entries will be displayed on the 2012 AAUW note cards to be mailed to tens-of-thousands of AAUW members across the country this spring. AAUW members will select three of the six winning designs that appear on the note cards by voting online once a week for their favorites. Past winning artists will serve as judges to select the other three winning entries.

LAF CASE UPDATE

During the first week of January, lawyer Susan Burke filed an appeal for the LAF-supported case *Cioca v. Rumsfeld.* The plaintiffs in the case are 28 current and former members of the military who allege that they were raped by co-workers and that the defense secretary's failure to act on the issue of sexual assault in the military amounts to a violation of their constitutional rights. On December 13, a U.S. district court judge granted the Department of Defense's motion to dismiss the case. Oral arguments will be held in the 4th U.S. Circuit Court of Appeals in the coming months.

Burke spoke to the LAF committee on January 6 to discuss the importance of the case. She believes the the institutional changes needed in the military are unlikely to be won on the courts, so she plans to keep the case in the legal system as long as possible to create a lot of media attention and hopes to inspire public pressure for legislation that can stipulate those necessary institutional changes.

Burke and several of the plaintiffs from the Cioca case are featured in *The Invisible War*, a new documentary about sexual assault in the military that was to premiere at the Sundance Film Festival in Utah on January 20. The filmmakers are working with Burke to create a petition related to the issue that also was to be released that day. AAUW will be posting a program opportunity on the national website on how AAUW members can help bring attention to the case and to the issue. Community efforts will be essential to bring about change.

PUBLIC POLICY

Mark your calendar for April 17th for Pay Equity Day in Jefferson City. We are going to have a two tier approach. State legislators and federal legislators will be contacted simultaneously with our marketing plan. More info to follow. *Crossing the line-Sexual Harassment at School* is available from AAUW. It's free, but shipping is approximately \$5.75.

Many of our members are educators - current or retired. The Public School Retirement System (PSRS) of Missouri is contributed to by all personnel that are certified to teach and are working in public schools in Missouri except in the cities of St. Louis and Kansas City. Such employees are exempt from contributing to the Social Security System while engaged in such employment.

If these employees engage in employment outside of the school district, they contribute to the Social System a certain percentage of their income in such outside employment. Many teachers who contribute to the PSRS also work outside jobs and also contribute to Social Security. One would think, upon retirement, that the teacher would receive a pension from PSRS in an amount reflected by the number of years in the system and would also receive a pension from Social Security in an amount reflected by the number of years in that system.

However, if a teacher has been in the PSRS for over five years, and upon retirement receives full retirement benefit from the system, that teacher WILL NOT receive the full Social Security pension amount that he or she is entitled to, but instead, a reduced amount. This is because a federal law was passed in the 1980's called the Windfall Elimination Provision (WEP) that reduces the Social Security pension to those employees who also receive a full PSRS pension. Is this fair? Of course not.

In addition, a widow (or widower) who is receiving a PSRS pension is NOT eligible for the full widow's (widower's) benefit from the deceased spouse's Social Security that would normally be paid to the widow or widower. This is a restriction called the Government Pension Offset or GPO.

The NEA and the NEA-Retired have been lobbying for several years for the repeal of the unfair WEP and GPO provisions. Missouri is one of 15 states whose educators are impacted by these provisions. Just prior to congressional adjournment, Senators John Kerry

Kirkwood–Webster Groves Branch AAUW RE:News page 5 (D-MA) and Susan Collins (R-ME) introduced the Senate version of the Social Security Fairness Act (S 2010) which would repeal the unfair GPO and WEP. The bill is a companion to the House version (HR 1332) introduced earlier last year by Representatives McKeon (R-CA) and Berman (D-CA). Please urge Senators Blunt and McCaskill to cosponsor the bill. SAVE THE DATE! WOMEN'S LOBBY DAY FOR APRIL 17 IN JC—HOUSE HEARING ROOM 2

FROM THE AAUW ACTION NETWORK

Your voice was heard! You helped protect women's access to contraceptive services!

After reviewing more than 200,000 comments from the public – many of them from AAUW Action Network members like you! – the Obama administration announced earlier today that almost all employers will have to include coverage for women's preventive health services, including contraceptive services, starting in August 2012. This is a victory for women's health, and would not have happened without our raising our collective and persuasive voice.

AAUW applauds the administration for releasing this rule, and is relieved the administration worked to protect women's rights to access preventive care including contraceptive services. This decision means that women's preventive services will be covered without co-pay or cost-sharing. As the Institute of Medicine put it when proposing what should be covered, "Positioning preventive care as the foundation of the U.S. health care system is critical to ensuring Americans' health and well-being. Women particularly stand to benefit from additional preventive health services." AAUW couldn't agree more.

SUPREME COURT DECLINES TO HEAR TITLE IX CASE.

In early January, the U.S. Supreme Court declined to hear a case challenging the Department of Education's test for compliance with Title IX. The case, *Equity in Athletics Inc. v. Department of Education*, argued that the elimination of several men's sports teams at James Madison University in Harrisonburg, Virginia, was unconstitutional. LAF filed a brief supporting the Department of Education and the compliance test, which requires schools to show that they have met one of three tests to comply with Title IX. The court's decision means that the school's move to eliminate the teams will stand.

NEARLY HALF OF U.S. POPULATION LIVES IN HOUSEHOLDS RECEIVING GOVERNMENT BENEFITS

Census data reveal that in the second quarter of 2010 approximately 48.6% of the national population lived in a household that received some form of government benefit. Since the start of the recession in 2007, more Americans than ever are seeking outside assistance through unemployment benefits, subsidized housing, Social Security disability, or the food stamp program (SNAP). Means-tested programs were the largest source of benefits to families; in the second quarter 34.4% lived in a household benefitting from food stamps, subsidized housing, Medicaid, or other programs. AAUW promotes the economic, social and physical well-being of all persons. Essential to that well-being are an economy that provides equitable employment opportunities, a reduction of poverty, and a livable wage.


