# THE ONE THING YOU MUST DO THIS SUMMER: Protect Students from Bullying and

Harassment

As the weather warms up and the sun comes out, students around the country can almost taste it: summer. Most kids celebrate the end of school because it means no more homework, no more waking up early, and plenty of time at the beach; but for some kids, it finally means a relief – albeit a short one – from the relentless bullying they encounter in the school hallways, on the playground, in the classroom, and countless other places in the school environment. This summer, take action to make schools free from bullying and harassment so students feel safe all year. Tell our senators: Bullying and harassment has no place in our schools, and it's time for Congress to act.

Although some federal laws address particular kinds of harassment, there is no comprehensive law to address bullying and harassment. The Safe Schools Improvement Act (S. 403) would fill that troubling gap in federal education policy. S. 403 would ensure states, districts, and schools have policies to prevent and appropriately respond to bullying and harassment.

AAUW Director of Public Policy and Government Relations Lisa Maatz spoke at the event about the need to engage everyone to pass the STOP Act (H.R. 1593).

The heart of LAF lies in the courageous plaintiffs we support and in the wonderful AAUW contributors who make the program possible. Through the LAF Case Support Travel Grant, AAUW members from 10 states will meet current or former LAF plaintiffs and hear their stories at spring AAUW state conventions. The Illinois-Missouri combined state convention, May 3-5 at the Ballpark Hilton in St. Louis, will feature Daniele Hoffman whose case is Hoffman v. Panetta. Every member has a voice and a chance to vote on the AAUW National by-law changes, President, Vice President and vote for 10 directors for the 2013-2015 term of office. The first step is to go to the AAUW website at www.AAUW.org. To pay on-line select Member Center, then scroll down to the bottom and click on Member Tools. Click on the visit here button near the bottom of the Member Services Database. You will be invited to click on enter member services database, click on it. If your name and data pop-up this is your personal data page. Review your information and change anything that is incorrect. Then, click on renew my membership. Fill in the credit card data. The \$74 dues are shown. Here you may also contribute to a fund. Click NEXT to continue. You will see review so you can check the information you just entered. Now click only once on submit. You will see an immediate thank you receipt and a confirmation will be emailed to your inbox. If your name does not pop up you may see a log in page that asks for your Member ID and Password, you will need to re-enter your information, even though the boxes look filled in. Just click on the boxes which will delete the text. Then, type in the information. Use links on this page if you need to jog your memory. This is for those who have registered before, but have not revisited the site for a while. If you have NOT logged in before, click need to register right below the log in-in boxes. Follow the directions and be sure to write down your password.

If you need to vote you will start with www.AAUW.org type vote in the search box. You should have received an email with your pin number to use to vote that is emailed from EON Support, subject 2013 Ballot. Be sure you check your SPAM folder. The PIN is also on the mailing labeling of your Spring/Summer AAUW Outlook. All voting will take place online unless a member sends a request to AAUW for a paper ballot. The online voting period is April 15 to June 10, 2013
