AAUW National has sent us three documents to share with AAUW MO members-the Missouri Governor Voter Guide, the Missouri Senate Voter Guide and the AAUW Voter Issue Guide. The Governor and Senate guides were specifically prepared for our state at the request of Karen Francis and Pat Shores. The Voter Issue Guide has questions that you can ask candidates about AAUW priority issues.

We Celebrated the Vote!

In 1916, over 3000 suffragists converged on Saint Louis, MO in the sweltering heat during the Democratic National convention poised to re-nominate Woodrow Wilson as President. Their sole demand was a plank in the party platform in support of women's suffrage. Wearing white dresses and golden sashes that said "Votes For Women" they lined the street where the delegates would walk from their hotel to the convention center. The impact of these women, who formed a 'walkless talkless parade', sometimes called "The Golden Lane" was enormous. They accomplished their objective and got the plank on the platform.

The Celebrate the Vote Festival on September 3 honored past suffragists and celebrated how far we have come. AAUW was one of the many sponsors of this event and was well represented by members from all St. Louis branches. Golden Lane Award recipients honored at the event included Adrian Bracy, Maxine Clark, Ann Geraghty-Rathert, and Dr. Beth Stroble.

Golden umbrellas, white "Votes for Women" tshirts and gold "Votes for Women" sashes were proudly displayed. Those attending from KWG are pictured below. The large group picture shows all the women who marched in the Festival's parade!

RESEARCH FINDS that *pecans are healthy!* Adding just a handful of pecans to a low-fat diet can dramatically lower LDL cholesterol as well as triglyceride levels. Pecans have good fats, which lower bad cholesterol, and do not affect good cholesterol. Pecans are naturally cholesterol-free and sodium-free and are high in unsaturated fats that promote and maintain good health. So - add pecans to cereal, salads, entrees, and vegetables; sprinkle them over fat-free yogurt; or even eat them plain as a snack. Enjoy not only their delicious taste but also the added health benefits.

STORING PECANS under refrigeration is the best way to retain the fresh aroma, color, and flavor of pecans. The lower the temperature, the longer the pecans will keep, although there is no critical temperature below which pecans must be held. Pecans stored in a refrigerator (38 to 40 degrees F) will keep for more than nine months. In the freezer at 0 degrees F they will remain in good condition for two years or longer. Unused pecans may be refrozen again and again without adverse effect on the quality or texture of the pecans.

Carole DeSaram is a VFA board member who is living history in the Second Wave of feminism front lines of the 1970's. Got a credit card in your name alone in your wallet? We all need to thank Carole, because in 1970 banks would not issue credit to single women. She was the first New York state director of NOW and the driving force to end credit discrimination against single women in 1974. On August 26, 1970 she was a lead organizer for the Equality March in New York City attracting over 100,000 women and some men to march down Madison Avenue. The modern women's movement became a national mass movement on that day.
