Tandy will tell us about the importance of the town of Ste. Geneviève, the preservation of the late 18<sup>th</sup>/early 19<sup>th</sup> Century homes, the new museum, the Centre for French Colonial Life ([www.FrenchColonialLife.org](http://www.FrenchColonialLife.org)), and the role of women in this world. She will show us pictures of a Jardin Potager (French for vegetable /kitchen garden), a rose garden which is thought to be the oldest formal rose garden west of the Mississippi, and Ste. Geneviève variety boxwoods . . . some of the tallest certainly the oldest boxwoods in Missouri (they are believed to be 260 years old) and, of course, the houses themselves.

Tandy, a Kirkwood-Webster AAUW member, is a long-time volunteer with the National Society of Colonial Dames of America in the State of Missouri. The "New France: The Other Colonial America" board was formed to oversee the management, fundraising, operations, etc., of the historic vertical log homes in Ste. Geneviève. Board members include a number of Dames and some names of note, Blanche Touhill, Peter Raven and John Karel.

Our AAUW-KWG scholarships encourage female participation (of all backgrounds) in the STEM fields. Hopefully, we will see the number of Black female astronauts grow.

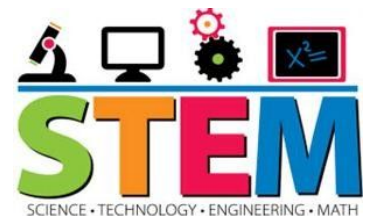


## Membership Dues 2018—19

As you know, the AAUW Board of Directors voted to increase the national annual membership dues from \$49 to \$59 in 2018–19. AAUW MO dues are \$10, and K-WG branch dues are \$15, which totals \$84 for the upcoming year. Fifty-six dollars of the national dues is tax deductible. The preferred method to renew is online. ## Public Policy

AAUW, for the following update.*

"Women's economic security is impacted not only by the pay gap, but by other laws." The 25th anniversary of the Family and Medical Leave Act (FMLA) was February 5. FMLA is the only national law that guarantees eligible employees time away from work when they have a new child, face a serious health condition, or need to care for an ill family member. FMLA passage was a significant initial step and an AAUW Action Fund Lobby Corps victory, yet it continues to remain out of reach for many workers. The law does not cover approximately 40 percent of employees. Those workers who are covered by FMLA can't always take advantage of it because unpaid leave means going without much needed income. When people have to choose between being there for their loved ones or their jobs, our families,

communities, and economy are adversely affected. It is time to fulfill the promise of FMLA by enacting a strong nationwide paid family and medical leave policy. Contact your legislators and urge them to pass the Family and Medical Insurance Leave (FAMILY) Act today.

Thanks to the efforts of Deb McWard, AAUW Missouri college-university liaison, the St. Louis Interbranch Council (IBC) has sent students of area college and university members to NCCWSL for the past several years. Six (now five) branches and generous individual members pool funds to pay for registration and airfare, plus extra funds to cover ground transportation and off-campus meals.

Recipients of this year's IBC scholarships to attend NCCWSL May 30–June 2, 2018, at the University of Maryland are:

- **Taylor Michl**, a junior at **Webster University**. Her majors are Women, Gender, and Sexuality Studies and Spanish. She is an undergraduate research assistant in the Psychology Department investigating the career development of psychologists working in oncology. She was chosen as one of ten student liaisons on the Student Conduct and Sexual Offense Hearing Boards. She also has been the development intern at Doorways, a nonprofit residential center for HIV+ people in poverty in Missouri and Illinois.

- **Shima Rostami**, a graduate student at **Lindenwood University**. She is working on her doctorate in education. She earned a B.S. in Islamic Jurisprudence and Law from Imam Sadiq University, Tehran, and an M.S. in Criminal Justice and Law Enforcement, Lindenwood (Belleville, IL). Shima is completing a research project that raises awareness of human trafficking on college campuses. She is willing to be the AAUW liaison at Lindenwood University. For the past two years, Shima has been the part-time program director for the St. Charles Coalition Against Human Trafficking (SCCAT) and has been the driving force behind three conferences open to the public. Under her leadership, SCCAT put together the first teacher training for Ft. Zumwalt School District (St. Peters, MO); represented MO at a regional conference by the Office of Violence Against Women in Kentucky; and has made connections with law enforcement officers, Homeland Security, U.S. Immigration and Customs agents, whom she often includes in presentations. She also is a member of AAUW Ballwin-Chesterfield.

### AAUW National

The AAUW Board of Directors voted in June 2017 to enact the first dues change in almost a decade. Effective March 16, 2018, national dues will increase from \$49 to \$59.

Annual dues currently account for 13 percent of AAUW's annual budget. They help to sustain and grow AAUW's programs and work that advances equity for women and girls. A combination of dues, donations, and corporate and foundation funding is critical to supporting AAUW's salary negotiation workshops, groundbreaking research, advocacy efforts, campus leadership programs, and so much more.

### February Meeting Synopsis

Dana Beteet Daniels, Senior Human Resources Consultant and Title IX Coordinator at UMSL, was our February 22, 2018 presenter. Dana shared an overview of the Title IX law, which impacts much more than sports, and everyone on campus, not just students. Title IX has expanded over time to cover all forms of sex discrimination, including sexual violence. The Office of Civil Rights is responsible for implementation of Title IX. All public schools and universities must have a Title IX Coordinator, beginning in 2011. Title IX was being used to protect transgender individuals under President Obama, but under President Trump these protections were rescinded. Universities are responsible for writing policy conveying discrimination. Professors and graduate assistants must be trained about Title IX policies. UMSL works to educate students with online training, meet and greets (to meet Title IX staff),

newsletters, and via the university's website. Training for students includes relationship training.

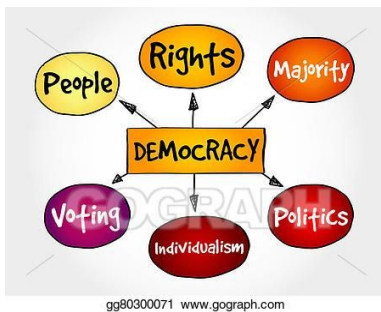
