As you know, the AAUW Board of Directors voted to increase the national annual membership dues from \$49 to \$59 in 2018–19. AAUW MO dues are \$10, and K-WG branch dues are \$15, which totals \$84 for the upcoming year. Fifty-six dollars of the national dues is tax deductible.

#### **Public Policy**

Thanks to Barbara Butchart & Eve LaJeunesse, Co-directors of Public Policy for Ballwin-Chesterfield AAUW, for the following update.

One of AAUW's 2017–19 Biennial Action priorities is the vigorous enforcement of Title IX and all other civil rights laws. AAUW and AAUW MO Public Policy have made the Title IX Coordinators Delivery Project a priority. Through this project, AAUW members are creating awareness about the purpose and provisions of Title IX: how students are coping in athletics; monitoring the gender ratio in STEM and Career and Technical Education (CTE); working to prevent and end sexual harassment and violence; and supporting pregnant and parenting students. The Title IX Coordinators Delivery Project gives AAUW branches an opportunity to build relationships with local Title IX coordinators to work together to commit to protect students' civil rights. Our branch will be assigned one or more school districts to

work with. Public schools K-12 must follow Title IX. https://www.aauw.org/resource/titleIXdelivery

Now more than ever, we need to protect our students as information continues to surface regarding what happened to our Olympic athletes, and how they weren't protected even though Title IX has been the law since 1972. The US Department of Education announced plans to open a Title IX investigation at Michigan State University to assess the institution's systemic issues in responding to the sexual misconduct allegations against Dr. Larry Nassar, a former faculty member now convicted on numerous accounts of sexual assault. The Office of Federal Student Aid, in conjunction with the Office of Civil Rights, has opened an investigation of the school's compliance with The Clery Act. AAUW urges a comprehensive review.

### STEM Scholarships

Kirkwood-Webster Groves awards two \$500 STEM Scholarships to high school seniors.

Jasmine Hunt is the 2018 recipient of the AAUW STEM Scholarship from Affton High School. This worthy young woman has high academic achievements. Hunt is a member of the National Honor Society with a weighted GPA of 4.3044. Hunt was a member of student council all four years of high school in her senior year Hunt served as the vice president. Other leadership involvements were attending Prevention Leadership Conference in 2016 and Family, Community, and Career Leaders of America.

While this recipient held academic and leadership positions, Hunt was also involved with Special Olympics, STUCO Breakfast with Santa Claus, Trick or Treat for UNICEF, and church volunteer. Hunt was a Scholar Athlete and a member of the Varsity Sports Club all four years of high school. During those four years, Hunt was a junior varsity and then a senior varsity cheerleader. Hunt also worked, first at Lion's Choice and then as a hostess at Syberg Restaurant from September of 2017 to the present.

Hunt took BIOMed classes through Project Lead the Way. At that time Hunt decided to be a pharmacist and plans to attend St. Louis College of Pharmacy

participating in a seven year program. This young woman is highly motivated in a difficult and challenging scientific program. The Kirkwood-Webster AAUW members wisheher the best for the future.

Amandi Muse Morris is the 2018 recipient of the AAUW STEM Scholarship from Maplewood-Richmond Heights (MRH) High School. She is an accomplished tennis player and classical pianist, winning awards in both. She is active in social justice, co-founding an organization that introduces tennis to young children from low-income urban communities and organized MRH students in creating an African-American History and Culture Club. The club sponsored talks, events, and collaborative activities with other school and St. Louis-area organizations.

Amandi served as a volunteer lab assistant at the University of Missouri-St. Louis (UMSL) and assisted graduate and undergraduate students in screening for haemoproteus and avian malaria in Galapagos Islands birds. She participated in weekly research team meetings with professor and students. Also at UMSL, Amandi served as a paid intern and documented the effect of the auxin hormone on the phenotypes and genotypes of genetically mutated and wild type Arabidopsis plants.

Amandi wrote in her scholarship essay: "My college plans include double majoring in biology and sociology, minoring in music, and possibly continuing my interest in competitive tennis. An important part of my college experiences will include melding scientific research with social justice." She wants to be "an active member of student organizations that support my academic and career development and interests, that affirm my racial and gender identities as an African-American female, and that allow me to continue my community engagement. Throughout my college experience, I plan to be in company with similar students who value academics, excellence, and equity and diversity." Amandi plans to earn a PhD in bio-genetics. We can't wait until Amandi graduates and becomes an active member of AAUW! She has many skills and talents to share!
