"Put Yourself Out There" Incentive
Grant Report

The AAUW Incentive Grant funds were well used to "Put Ourselves

Out There." KWG participated in two festivals one week apart! The Greentree Festival in Kirkwood was on September 15 and 16, 2018. The festival was busy, but not as busy as September 2017 because it was blazing hot! We talked to many interested people, received \$65 in donations, and I discovered that there are many college-age women who are interested in AAUW issues. In my opinion, I think AAUW needs to hyper-focus on starting university chapters in order for AAUW to grow. Or, if students don't want to run a student chapter, AAUW branches could host more events for high school and college women. Students are interested in movies, canvassing, marches, and selfies. I think we can tailor events specifically to young women. However, our branch is small and we can only do so much.

The second event was BookFest St. Louis in the Central West End. This event was just perfect for us! The weather was nicer, but the audience was much more targeted. We showcased a large collection of AAUW research: both the books and the executive summaries. Some of them have been stored in our homes for 10 years and we gave all of them away! We also shared books about women and by women as recommended reading. Marsha texted me (I was at another event for part of the day) that everyone loved the recommended books. She suggested we write a recommended book list for MiM and branch newsletters. Great idea! For this event I purchased a counter. Kay did a great job of clicking for every person we talked to and, amazingly, we talked to 171 people! No wonder everyone went home tired!

At both events, people voted for the issue they thought was most important. Their choices were: pass ERA, protect gender civil rights, health care for all, end human trafficking, equal pay, better funded public education, protect reproductive rights, end sexual harassment and violence, promote STEM careers for

women, and maintain Title IX. Many people voted for more than one, stating that it was impossible to choose just one. We still need to count the votes - there are hundreds of little chits to count! More on that in a future report.

In our grant we said we would conduct two outreach events, and we did. I am still looking for an event in Webster Groves since we are the Kirkwood Webster Groves branch. Mara and I talked about possible events, and the city of Webster Groves does not host any public events like the Greentree Festival. I would like to apply for the grant again to purchase two things to make our tabling events more professional: a tablecloth with our name printed on the front and a banner to hang on the canopy. (We did purchase a canopy this year.) We must continue to "put ourselves out there" to meet our mission of "equity for women and girls."

AAUW, in collaboration with AAUW members, local and state governments, businesses, colleges and universities, and non-profit organizations across Kansas and Missouri, will empower 1,000,000 women with the skills to confidently and successfully negotiate their salaries and benefits, fundamentally improving the lives of women and their families, increasing consumer spending with local businesses, and increasing local, county, and state tax revenue. Missouri and Kansas AAUW members participated in a call with Kim Churches on September 24 to learn more. All initiatives will be staged and sequenced so we can be as successful as possible together.

Public Policy

The three major focuses of AAUW MO public policy are:

- · Get Out the Vote
- · The Protection and Enforcement of Title IX
- · Closing the Gender Pay Gap

Pat Shores and Ellen Irons, state public policy chairs, will ask each branch to plan at least one activity around each of these focus areas. Yvonne Blair, as KWG public policy chair, will lead our efforts.

The Missouri Women's Network legislative retreat will be on Saturday, January 12, in Columbia. Training will be featured on FASTdemocracy.com, a new program to track legislative action. The annual lobby day/equity action day is Tuesday, April 16, at the state capitol.

AAUW MO Missouri Ballot Issues

AAUW MO recommends the following positions on the issues scheduled to be on the November 2018 ballot in Missouri:

SUPPORT

- Amendment 1, Lobbying, Campaign Finance and Redistricting Initiative (Clean Missouri)
- Proposition B, \$12 Minimum Wage Initiative

Amendment I: Would change the MO Constitution to limit campaign contributions to \$2500 for office of State Senators and \$2000 for State Representatives; require a non-partisan state demographer design plan for appropriateness and map districts with goal of partisan fairness and competitiveness; require a "cooling off" period of two calendar years before a member of the General Assembly or their staff can become a paid lobbyist (known as Clean Missouri).

Reasons for support: The 2017-2019 AAUW Public Policy Priorities, Principles for Action states "there is an urgent need for meaningful campaign finance reform, open and fair elections, and non-partisan efforts that promote equitable political participation and representation in elected offices." Missouri has no campaign contribution limits. Lobbyists provide more than \$870,000 in gifts to state representatives and senators annually. Half of the General Assembly races in November 2016 had a single candidate on the ballot. Amendment 1 has bipartisan support and will "level the playing field" so individuals and corporations with access to money will not have a greater influence in elections and policy making.

Proposition B: Raising Minimum Wage-this issue would, over a five year period, raise the minimum wage from the current \$7.85 to \$12.00 in 2023; government employers are exempt; private sector employers who fail to comply would face penalties; this proposition would guarantee the rate.

Reasons for support: The 2017-2019 Public Policy Priorities, Principles for Action: "AAUW promotes the economic, social, and physical well being of all persons. Essential to that well-being are an economy that provides equitable employment opportunities; reduction of poverty; a living wage......" and AAUW's Biennial Action Priorities: "To achieve economic self

sufficiency for all women, AAUW advocates for pay equity in compensation and benefits." According to the National Women's Law Center, seven in ten minimum wage earners in Missouri are women. We realize \$12 is not a livable wage but this Proposition increases salaries by \$4.15 in five years. In 2016 the Economic Policy Institute found that for every \$1 increase in minimum wages the amount of workers receiving public assistance is reduced by over 3%. By 2023, the share of workers receiving public benefits would be reduced by close to 10%

Shape the Future Membership Campaign

New members who join at a public AAUW event, such as one of our monthly meetings or our table at the Greentree Festival, can take 50% off the cost of their first year's national dues. AAUW national dues are \$59, of which \$56 is tax deductible by the individual member; \$3 of that national dues payment is not tax deductible because it is used to support the AAUW Action Fund's Section 501(c)(4) activities (Lobby Corps and election-related activities).

highest antioxidant capacity. Antioxidants are powerful nutrients that slow the aging process and reduce the risk of cancer, heart disease, diabetes, and Alzheimer's. Remember: Pecans can be kept fresh in the freezer for up to two years, so go ahead and get a whole case!

STORING PECANS under refrigeration is the best way to retain the fresh aroma, color, and flavor of pecans. The lower the temperature, the longer the pecans will keep, although there is no critical temperature below which pecans must be held. Pecans stored in a **refrigerator** (38 to 40 degrees F) will keep for more than nine months. In the **freezer** at 0 degrees F they will remain in good condition for two years or longer. Unused pecans **may be refrozen** again and again without adverse effect on the quality or texture of the pecans.



The pecans should be delivered before the holiday baking season, depending on the growing season and weather. Please make checks payable to "AAUW K-WG Branch."
