Message from President Chris Nobbe

Every election people say "this is the most important election" but I think November 6 really IS important! This newsletter includes ballot information on pages 5 and 6.

The ballot is the longest ballot ever in Missouri with a minimum of 45 choices. Please use the sample ballot mailed to you, the one printed in the St. Louis Post Dispatch, or the one <u>online</u> to prepare. You may take a sample ballot with you to the ballot box. My recommendation is to go early and be prepared with a snack and reusable water bottle. You might be in line a long time, based on the absentee voting waits being reported. If you have trouble standing you might want to take a folding stool so you can sit.



K-WG worked to educate people about the ballot issues by hosting two "Fall Ballot Issues" events - one was at our regularly scheduled meeting on October 18 and was was at the Oak Bend Library on November 1. At both

events Nancy Price (on left in the photo) from the League of Women Voters made the presentation. At our monthly meeting 20 people attended and 11 were visitors! On November 1, we had 22 attendees, one speaker, and a baby.

<u>Work Smart Online Has Launched — Now Help Us</u> <u>Mobilize a Million</u>

Last week, AAUW launched a free, online version of its Work Smart course, which teaches women how to negotiate for higher salaries and become better leaders and communicators. **We're now asking all AAUW members to take the one-hour curriculum — and then ask 20 women in your life to do the same.** With your help, we can reach the goal of our "Members Mobilize a Million" campaign. Read The Simple Truth about the Gender Pay Gap

AAUW's recently released update to *The Simple Truth* found that women are losing a staggering \$500 billion in earnings each year due to the gender pay gap. The research report digs into the causes and consequences of the difference, and analyzes how the pay gap affects women in diverse geographic locations and of various ages, races, occupations, and education levels. AAUW's press outreach for the report yielded 127 media clips — including stories by USA Today, U.S. News and World Report, MarketWatch, Good Morning America, and numerous NPR affiliates — which reached more than 140 million readers within a week.

Women of every race and ethnicity experience a gender pay gap, but Latinas face one of the most egregious differentials: They are compensated barely more than half (53 percent) of what non-Hispanic white men are paid. That means it would take Latinas until November 1, nearly an extra year of full-time work to earn what men took home by the end of the previous year.

AAUW MO NOVEMBER BALLOT POSITIONS

AAUW MO recommends the following positions on the issues scheduled to be on the November 2018 ballot in Missouri:

➤ SUPPORT (Yes Vote)

- Amendment 1- Lobbying, Campaign Finance and Redistricting Initiative (Clean Missouri)
- Proposition B \$12 Minimum Wage Initiative

Amendment 1: Lobbying, Campaign Finance and Redistricting Initiative

Description: Would change MO Constitution to limit campaign contribution to \$2500 for office of State Senate and \$2000 for State Representative; require a non-partisan state demographer design plan for appropriateness and map districts with goal of partisan fairness and competitiveness; requires a "cooling off" period of two calendar year before member of the General Assembly or their staff can become a paid lobbyist. (known as "Clean Missouri")

Reasons for support: The 2017-2019 AAUW Public Policy Priorities, Principles for Action states "there is an urgent need for meaningful campaign finance reform, open and fair elections and non- partisan efforts that promote equitable political participation and representation in elected offices". Missouri has no campaign contribution limits. Lobbyists provide more than \$870,000 in gifts to state representatives and senators annually. Half of the General Assembly races in November 2016 had a single candidate on the ballot. Amendment 1 has bi-partisan support and will "level the playing field" so individuals and corporations with access to money will not have a greater influence in elections and policy making.

Proposition B: Raising Minimum Wage

Description: This issue would over a five-year period raise the minimum wage from current \$7.85 to \$12.00 in 2023. Government employers are exempt and private sector employers who fail to comply would face penalties.

Reasons for support: From the 2017-2019 Public Policy Priorities, Principles for Action: "AAUW promotes the economic, social and physical wellbeing of all persons. Essential to that well-being are an economy that provides equitable employment opportunities; reduction of poverty; a living wage......" and AAUW's Biennial Action Priorities: "To achieve economic self-sufficiency for all women, AAUW advocates: pay equity in compensation and benefits." According to the National Women's Law Center, seven in ten minimum wage earners in Missouri are women. We realize \$12 is not a livable wage but this Proposition increases salaries by \$4.15 in five years. In 2016 Economic Policy Institute found that for every \$1 increase in minimum wages, the share of workers receiving public assistance is reduced by over 3%. By 2023, the share of workers receiving public benefits would be reduced by close to 10%.

BREAKING NEWS ON VOTER ID REQUIRED AT THE POLLS

On Oct 24th, 2018, the Post Dispatch's stltoday on-line paper carried a breaking story on voter ID requirements at the polls on November 6th. A brief summary of the current ruling is: "Anyone who is registered and presents any ID will get to vote. <u>No one can be made to sign a legal statement if they opt for a non-photo ID.</u> Poll workers cannot tell voters that a photo ID is required." STORING PECANS under refrigeration is the best way to retain the fresh aroma, color, and flavor of pecans. The lower the temperature, the longer the pecans will keep, although there is no critical temperature below which pecans must be held. Pecans stored in a **refrigerator** (38 to 40 degrees F) will keep for more than nine months. In the **freezer** at 0 degrees F they will remain in good condition for two years or longer. Unused pecans **may be refrozen** again and again without adverse effect on the quality or texture of the pecans.



The pecans should be delivered before the holiday baking season, depending on the growing season and weather. Please make checks payable to "AAUW K-WG Branch."
