But the Constitution writers did not intend for the court to have such a dominant role. They viewed the judiciary as merely one branch of government. They gave Congress and the President, as well as state governments, various ways to check the court's power and even undo the effects of rulings.

Besides the voter's decision to protect abortion in Kansas, Congress has taken action on same-sex marriage. The House-approved measure protecting same-sex marriage is awaiting passage in the Senate. Never has voting to choose our leaders been more important than it is now.

I am glad we are doing a small part in our **Get Out the Vote** sign project that we initiated with the Metro St. Louis League of Women Voters. The sign includes the website VOTE411.org that has voter information by zip code.



AAUW of Missouri funded 10 signs for every branch in Missouri. Eleven of the 16 Missouri branches have received their signs with Canton and Cape Girardeau waiting for delivery. The others, Joplin,

Nevada, and Maryville, have yet to contact us about getting their signs. If no one is able to pick them up or deliver them to their area, we will ship their signs.

Our branch decided to give a sign to every member who wanted one. If you haven't

gotten a sign, contact me (Jeannewebdell@gmail or 573.754.0943) to pick up a sign or have it delivered to your home or office. If your yard is not a good place, find someone else with a good location to put up the sign. Becky Clausen's sign is pictured at above left.

The 10 free signs we received from the State AAUW are being distributed to public places, elected officials, and media people. If you know someone or some place in those categories that will accept a sign, let me know.

It's important that we help voters be informed so they can make good choices.

This annual Greentree Booth tabling event is an opportunity for our branch to fundraise and inform the public of our efforts for equity for all people. Our 2022 Kirkwood Greentree Festival Booth will continue to be designed to draw issues-oriented visitors.

Once again, visitors to the booth will be asked to share where they see inequities in their community. There will be a special display that allows people to vote for their choice of the three top issues facing women today. At our booth in 2021, reproductive rights gained the most votes. The 2021

poll voting results were

- preserve reproductive rights, 113
- health care for all, 74
- eliminate the pay gap, 73
- stop human trafficking, 70
- pass the ERA, 69
- protect voting rights, 66
- promote STEM careers, 38.

A number of people signed up to receive further information about AAUW and our branch.

AAUW METRO ST LOUIS INTERBRANCH COUNCIL (IBC)

This is a great opportunity for one or two of you to get to know AAUW members in other St. Louis branches! Please consider volunteering for this low-key role!

KWG is **one of the five branches** that form the AAUW Metro St. Louis Interbranch Council, more commonly known as IBC. They meet 4 times a year, some virtually and some in person. Each branch is allowed 3 voting delegates, and historically the officers of each branch have served as those delegates. For the 2022-23 year, these officers are serving as delegates, each having ½ a vote when both attend a meeting or 1 vote when only one attends:

CO-PRESIDENT: Jeanne Webdell and Marsha Koch CO-PROGRAM VP: Chris Nobbe and Kay Meyer KWG is entitled to another voting delegate.

The purpose of IBC is

- To foster cooperation among member branches and to financially support programs and projects.
- To open channels of communication among branches for the sharing of ideas and interests.

What does IBC do?

- Sponsors an annual event at which Barbara Lackritz Awardees are honored
- Sponsors fundraising activities for student scholarships to NCCWSL (AAUW's National Conference for College Women Student Leaders)
- Printing of AAUW bookmarks with branch websites for placement in public locations such as libraries
- Special projects
- Share program, interest group, and fundraising ideas among branches
- Collaborate on new projects

Several committees exist to do the detailed work required for:

NCCWSL

- Solicit scholarship applications from C/U members
- Select scholarship recipients
- Lead fundraising activities
- Facilitate scholarship recipients' trips to NCCWLS

Barbara Lackritz Award (has guidelines)

- Provide branches with application information
- Plan and present awards at the IBC annual event
- Prepare a Barbara Lackritz printed program for the IBC annual event

IBC Annual Event (has guidelines and a playbook; one member from each branch)

- Determine date, venue, and menu of the event
- Coordinate selection of speaker/entertainment
- Coordinate fundraising activities at the event
- Publicize the event to branches


- Prepare a printed program for the IBC annual event

A new state law could lead to more prosecutions in Missouri of human traffickers

A new state law could lead to more prosecutions in Missouri of human traffickers. Governor Mike Parson recently signed into law House Bill 1472 to change in state law definitions related to currency and money laundering. That might not sound like trafficking legislation, but advocates say it is.

"Remember, for traffickers human trafficking is about making the highest profit possible with the lowest risk to get caught by law enforcement. This is the key. For that reason traffickers need to find ways to eliminate anything, any ways that could lead law enforcement and authorities to them ... or be used as evidence," said Dr. Shima Rostami, executive director of Gateway Human Trafficking based in Chesterfield. "For that reason, virtual currency and engaging peer-to-peer mobile payments has been playing a great role for payments concerning trafficking operations lately and because the laws haven't been updated ... to help prosecutors and law enforcement use the evidence they can gather from these forms of transactions, it's been very difficult for prosecutors and law enforcement to follow the footprints of traffickers in trafficking operations."

Dr. Rostami says prosecutors are often left with no evidence aside from the testimony of victims, and victims often refuse to testify. This can be for many reasons stemming from their experience, including traumas they suffered or because trafficking organizations may still have leverage over them such as threats against their families or even holding family members hostage.

HB 1472 adds to state law definitions for "cryptocurrency," "financial transaction," and "transaction;" and replaces the definition for "currency" with one for "monetary instruments." It was sponsored by Representative Patricia Pike (R-Audrian), who has worked on several trafficking issues during her 8 years in the House. She said those continue to be important in Missouri because its location makes it important for trafficking.

The House voted 141-2 to send that bill to Governor Parson.

St. Louis has a rich history of journalism that most of us tend not to think about when we are watching the weather forecast or listening to our favorite radio station. We may be familiar with Joseph Pulitzer, a Hungarian Jewish immigrant who founded the St. Louis Post Dispatch. Pulitzer paved the way for newspapers across the country and used his influence to advocate on behalf of immigrants. But there has to be more, right?

To help us learn about the history of journalism in St. Louis, NCJWSTL is excited to welcome Bill Freivogel, professor in the Southern Illinois University School of Journalism, contributor to St. Louis Public Radio, and publisher of the *Gateway Journalism Review*. Previously, he was director of the Journalism School. Before SIU, Freivogel worked 34 years at the *St. Louis Post-Dispatch*, where he was assistant Washington Bureau chief and deputy editorial editor.
